All dogs that come to this event have to be insured and have to have a valid rabies vaccination. This is also valid for dogs not competing at the trial.

Please take your vaccination certificate with you.

Should he come to control the vaccination certificates and find that a dog is not vaccinated sufficiently, this dog will be disqualified.

From Tiolosenmäki (Nesteoil) left to Kitee, drive trough to town about 6-8 kilometers , comes stop cross , drive over it direct to Juurikka/Närsäkkälä 17 kilometers , turn right to Konitola 2, 800 meters straight and our facility is on the left

6 – high way from south:

Turn right from 6 high way to Kitee 10 , Drive about 9 kilometers and turn right to Korkeakangas, drive about 1-2 kilometers turn right Närsäkkälä/Juurikka, drive 17 kilometers and turn right to Kontiola 2 , drive 800 meters straight and our facility is on the left
